Income Tax (Exempt Entities) (Jersey) Order 2026

Minister for Treasury and Resources.

This Order exempts the income derived from the property of the following entities from income tax: Andium Homes Limited and the Parish of St. Martin Housing Association. The exemption is made under Article 115(2) of the Income Tax (Jersey) Law 1961. The Order comes into force 7 days after it is made.

Highways (Exemption for Campaign Advertising Material) (Jersey) Order 2026.

Minister for Infrastructure.

This Order provides for an exemption from the general prohibition in Article 2(1) of the Highways (Jersey) Law 1956 on placing anything below, on or above a highway. The exemption allows campaign advertising material relating to an election or referendum to be placed above a highway during the campaign period, if the material and its placement comply with the conditions specified in the Schedule. “Campaign advertising material” and “campaign period” are defined in Article 4A of the Highways (Jersey) Law 1956.

Article 1 provides for the exemption from the general prohibition.

Article 2 gives the title of the Order and provides for it to come into force 7 days after it is made.

The *Schedule* specifies the conditions as to the manner and placement of campaign advertising material, for the purposes of the exemption in *Article 1*. The conditions include conditions relating to the location, the material and the time and manner of placement of campaign advertising material.

This Order comes into force 7 days after it is made.
