REPORT

On 13th August 2026, the Chief Minister made a Ministerial Decision delegating certain of his functions under Articles 28, 30 and 30A of the States of Jersey Law 2005 (see Decision reference MD-CM-2026-486, available at www.gov.je).

The terms of the delegations, and the legislation under which those delegations were made, were recorded in a Report attached to the Ministerial Decision, as shown below.

It should be noted that this is an update to R.137/2026.
