## REPORT

In accordance with Article 25(1)(a) of the States of Jersey Law 2005 (“the 2005 Law”), the Minister for External Relations appoints Senator Alan Maclean as an Assistant Minister.

In accordance with Article 28A(1) of the 2005 Law, Senator Maclean is delegated the full range of functions and responsibilities relating to financial services, intellectual property and trademarks, and sanctions and asset freezing (as outlined in the table below). The Minister also delegated all his External Relations functions to Senator Maclean in circumstances where the Minister and Senator Elaine Millar are away from the Island and/or temporarily absent.
